The Volunteer and Guardian hereby freely, voluntarily, and without duress executes this Release under the following terms:

**Release and Waiver.** Volunteer and Guardian do hereby release and forever discharge and hold harmless Leland Bridge Parents Group, and its directors, officers, and event coordinators and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which may arise or may hereafter arise from Volunteer's Activities with Leland Bridge Parent Group. Volunteer and Guardian understand that this Release discharges Leland Bridge Parents Group from any liability or claim that the Volunteer or Guardian may have against Leland Bridge Parents Group with respect to bodily injury, personal injury, illness, death, or property damage that may result from

Volunteer's Activities with Leland Bridge Parents Group, whether caused by the negligence of Leland Bridge Parents Group or its officers, directors, or event coordinators. Volunteer and Guardian also understand that Leland Bridge Parents Group does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

**Medical Treatment.** Volunteer and Guardian do hereby release and forever discharge Leland Bridge Parents Group from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Leland Bridge Parents Group.

**Insurance.** The Volunteer and Guardian understand that Leland Bridge Parents Group does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

**Photographic Release.** Volunteer and Guardian do hereby grant and convey unto Leland Bridge Parents Group all right, title, and interest in any and all photographic images and video or audio recordings made by Leland Bridge Parents Group the Volunteer's Activities with Leland Bridge Parents Group.

**Other.** Volunteer and Guardian expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California, and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
